**ORDER**

The Vice Chancellor, IGDTUW is pleased to constitute a three members, consisting of the following members (by name), to examine whether a case of plagiarism has happened in any document and it is fit to be examined by the Departmental Academic Integrity Panel (DAIP):

- (i) Prof. Ashwani Kumar : Professor, Deptt. of ECE/ Dean (International Affairs), IGDTUW.  
(ii) Dr. Ranu Gadi, : Associate Professor, Department of BAS/ Dy. Dean (IRD), IGDTUW.  
(iii) Dr. Vivekanand Jha : Assistant Professor, Department of CSE, IGDTUW.

The above Committee shall investigate and examine the matter and keep all proofs and evidences relating to happening of plagiarism in any document. If the said Committee suspects with appropriate proof, after obtaining appropriate proofs to the satisfaction of the Committee from the complainant, clarification from the staff/faculty against whom complaint(s) relating to plagiarism made and after seeking necessary clarifications from the concerned author(s) etc. if found necessary, that a case of plagiarism has happened in any document, it shall report it to the Departmental Academic Integrity Panel (DAIP). The recommendation of the DAIP shall be placed by the said Committee before Institutional Academic Integrity Panel (IAIP) for necessary investigation & recommendations. The recommendations of the IAIP shall be forwarded to the Vigilance/Personnel Branch, IGDTUW for taking further necessary action for initiating disciplinary proceedings per CCS (CCA) Rules, 1965.

Dr. Ranu Gadi, Associate Professor, Department of BAS/Deputy Dean (IRD), IGDTUW with the support of Dr. Vivekanand Jha, Assistant Professor, Department of CSE, IGDTUW, shall process the matters relating to plagiarism and place the same before the above Committee and DAIP & IAIP. The recommendations of IAIP shall be forwarded to the Vigilance/Personnel Branch, IGDTUW for taking further necessary action for initiating disciplinary proceedings as per CCS (CCA) Rules, 1965.
